He married (2) MARY BAUCOM October 1799 in Pendleton District, SC, daughter of UNKNOWN BAUCOM and UNKNOWN WIFE.

Notes for LEWIS WIMBERLY:

Lewis was born in 1744 -- that date is deduced from the Bertie County Court Minutes of 9 Nov 1742 where "Thomas Wimberley proved his Rights ..." by listing himself, wife Mary and children Judy, Abraham, Jacok (Isaac), Jacob, Susannah, Malachy, Selfey and Thomas, Jr. These were all apparently in order of age, so Lewis wasn't born yet. By 1755 when Thomas' estate was divided among the children, William, Lewis, Mary and Sarah had been added to the list. Since Thomas, Jr., from other records was probably born about 1740, William probably came along late in 1742 or early 1743 and our Lewis in 1744.

Another reinforcement of this Lewis' age is that he sold land presumably inherited from his father in 1765, probably about the time he turned 21 so we're back to a birthdate of 1744, again. It has to be this Lewis who went to Chatham Co. with his elder brother Jacob -- they had adjoining property there -- and some of the Barbees were also in that neighborhood.

Also, remember that Martha Barbee's father located nearby in that part of Orange Co. which later became Wake Co. Jacob started having land surveyed in Chatham Co. in 1779 and he and Lewis both received land grants there from the state in 1780.

Lewis Wimberly served in the Revolutionary War army and performed Patriotic Service (PS) during the war. He served from North Carolina and is listed in the DAR Patriot Index Centennial Edition, Part III, 1994, Page 3253.

Lewis Wimberly moved from the Pendleton District of South Carolina in either 1802 or 1803 and moved to Sumner County (later Smith and Wilson Counties) Tennessee. The Wimberlys were an early Bertie County, NC family.

Lewis may have been living in Chatham County, NC in 1790 where a man of that name had as neighbors Jesse Tatum and Solomon Smith, who were enumerated in Pendleton in 1800 along with a Moody family from Chatham County.

In the Chatham County, NC Court Minutes, 1773-1779 on the list of Jury members to lay out a road from the Orange Co. line near Henry Beasleys, are next named Lewis M. Wimberly and his brother, Jacob Wimberly.

Lewis M. Wimberly must have moved to Pendleton District of SC in the fall or winter of 1792. He purchased land in Pendleton Co. in January 1793.

George Salmon, of Greenville Co, S.C. on January 31, 1793 sold to Lewis Wimberly, of Pendleton County, S.C. 300 acres of land for £65 Sterling, part of a tract granted Salmon on June 4, 1787 on both sides of the South Fork of 12 Mile River, bounded by Duncan Camron and Earle. Witnessed by Sarah and Wiat Anderson

On October 30, 1802, Lewis Wimberly sold 200 acres of land on the South Fork of 12 Mile River bounded by

Salmon's land to Charles Lay for the amount of \$120. The transfer was signed by Lewis Wimberly and Polly Wimberly made her (x) mark. It was witnessed by John Field.

On October 30, 1802, Lewis Wimberly sold 300 acres of land on the South Fork of 12 Mile River bounded by Porter, Cannon and Earle to Charles Lay for the amount of \$900. The transfer was signed by Lewis Wimberly and Polly Wimberly made her (x) mark. It was witnessed by John Field.

With these transactions, Lewis Wimberly sold his holdings in South Carolina and prepared to travel to Sumner County (later Smith and Wilson Counties) in the fall of 1802 or the spring of 1803. My guess is Lewis left on November 1, 1802 and arrived in Smith County late in November, traveling about 10 to 15 miles per day. By 1802, there were well established roads from South Carolina to Tennessee. The road Lewis probably traveled on was the one that went north into North Carolina, then over the Smokey Mountains into Knoxville, then west to Carthage, or Lebanon, or Hartsville, TN which are the county seat of Smith, Wilson and Trousdale County.

Sumner County was divided into three counties, Wilson, Sunmner, and Smith in 1799. In 1870, Trousdale County was formed by taking parts of Macon, Smith and Sumner Counties. Lewis could have lived in either what is now Trousdale or Smith Co.

Lewis Wimberly of Smith County, Tennessee Last Will and Testament March 3, 1817 Proved August 1817

BE IT KNOWN TO ALL MEN, that I, Lewis Wimberly, of the County of Smith, (State of Tennessee) being in low state of body but in perfect mind do make and ordain this Instrument of writing to be my last Will and Testament.

First: I give and bequeath or rather lend unto my beloved wife Polly Wimberly my plantation being on a three hundred acre tract where I now live with all priviledges belonging thereof during her natural life or widowhood also including Farming utentials, household & kitchen Furniture including every pieces of property that I am now in possession of except some articles that I shall here after name:

Secondly: The property that I give my Daughter Polly Yates I consider it is to be her full portion of my estate.

Thirdly: I consider the property that I have given unto my daughter Sally Bird to be her full portion of my estate.

Fourthly: I consider the property that I have already gave unto my daughter Betsey Yates to be her full portion of my estate.

Fifthly: The property that I have already gave unto my son Isaac Wimberly I consider to be his Faull portion of my estate.

Sixthly: The property that I have before gave unto my son Noah Wimberly I consider it to be his full portion of my estate.

Seventhly: The property that I have allready gave unto my daughter Winney Winfrey I consider it to be her full portion of my estate.

Eightly: The property that I have allready gave unto my son Hardy Wimberly I consider it to be his full portion of my estate.

Ninithly: The property that I have allready gave unto my daughter Edy Baren I consider to be her full portion of my estate.

Tenthly: My daughter Roady Miller I give & bequeath unto her ten dollars worth of property to be her full legacy in my estate.

Eleventhly: I give and bequeath unto my son Enock Wimberly ten Dollars worth of property to be his full portion of estate.

Twelvethly: I give & bequeath unto my Daughter Patsy Barker one bed as she has already received to be her full portion of my estate.

Thirteenth: I give & bequeath unto my son Lewis (Luke) Wimberly ten Dollars worth of property to be his full portion of my estate.

Fourteenthly: I give & bequeath unto my Daughter Dicca Wimberly Ten Dollars worth of perperty to be her full portion of my estate.

Fifteenthly: I give and bequeath unto my son Elijah Wimberly my land & plantation as before mentioned after the death of his mother is to full possession of on condition that he takes good care of his younger Brother & Sisters in providing for their natural support until such time as they may become of full age, also to furnish my sons Thomas Wimberly and Washington Wimberly with one hundred Dollars each in property when they may become of lawful age, also my daughter Susannah Wimberly, Betsey Wimberly, & Milly Wimberly I give and bequeath unto each of them ten Dollars worth of property to be made out of my estate whereever they are either of them may marry or become lawful age on condition that Elijah Wimberly my son shall or fail to stay with his mother & provided & take good sufficient care of the family before named according to the times meaning as before inserted he is to have only an equal part of said Land with his other two brothers Thomas Wimberly & Washington Wimberly.

I also nominate & appoint James Montgomery & Josiah Howell my executors in this my last Will & Testament.

In withness whereof I have hereunto set my hand and Seal this 3rd day of March, AD 1817.

More About LEWIS WIMBERLY: Buried: Smith County, TN

Notes for MARTHA BARBEE:

Martha Barbee had children (13 total) until she was in the early 50's. She died in childbirth with her last child, Dicca, in early 1799. Lewis immediately found another young woman (in her early 20's), Mary "Polly" (Baucaum) with whom he then proceeded to have six more children. (19 total)

Notes for MARY BAUCOM:

Polly (Mary) was living in Smith County, TN in 1820. She still had Elijah (19), Thomas Jefferson, Washington, Susannah, Betsey, and Milly living at home. (6 in all) Polly had to raise the children until Elijah was old enough

to take them to Illinois.

I'm assuming Polly was 26 years old when Lewis married her in 1800, so her birthdate would be 1774. In 1820, she was 46 years old, being at the end of her child-bearing years. She probably died at the age of 56, or 1830, because she does not appear in the 1830 census of Smith County, TN nor does she appear in the 1830 census of Jefferson County, IL Elijah and all of her sisters and brothers do appear, however, in the 1830 census of Jefferson County, IL However, there is a listing for a Mary Wimberly (age 76) in Stewart County, TN in 1850 who was living with a Penina King (female) who was born in North Carolina and was 55 years old.

I cannot find any "Polly" in cemeteries in IL where other Wimberly's are buried. She must be buried in TN.

Lewis moved from the Pendleton District in SC in 1800 to Smith County TN right after he married Polly (Mary) Baucaum. He then proceeded to have five (6) more children, Elijah, Thomas Jefferson, Washington, Susannah, Betsey and Milly in the next 17 years until his death in 1817.

Enoch Wimberly was born in Pendleton District of South Carolina. He moved to Smith County, TN with his parents about 1802-1803. In 1814, Enoch married and soon got the urge to move to better farm land. He moved, with his family, to St. Charles County, Missoui, in about 1817.

Enoch Wimberly was listed in the Upper Quivre Township in the County of St. Charles, MO in the census of 1817. The census listed two persons of 18 and under 45, and two white females under 14 years of age. This would have been Elizabeth and Mary Wimberly.

Enoch Wimberly bought land on February 2, 1818 in St. Charles County. He purchased 157 and 80/100 acres. Sections or parts of section NW by E, Section 22 of Township 48, Range 1NW, near Reling Stream. John Armstrong purchased 159 40/100 acres in the SW part of this section.

The road to St. Charles in about 1817 was very busy. The settlers using this road west were mostly from Kentucky and Tennessee. The Kentuckians could be distinguished by their full blue jean suits; the Tennesseans wore brown jean coats and striped cotton trousers. During October of 1817, no less than 270 wagons and four-wheeled carriages and 50 two-wheel carriages and carts passed along the road, taking not less than 3,000 persons into St. Charles County. It was estimated that some 12,000 settlers preceded them at a rate of about 20 wagons per day.

Notes for CALEB Y. WIMBERLY:

Caleb Y. Wimberly was a SGT. of Company H, 30th Mississippi Regiment. He was captured on October 11, 1862 at Harrodsburg, KY. He was sent to Alton, Madison Co, Illinois for imprisonment. He died on January 28, 1863 of Erysihilas.

Conditions in the prison were harsh and the mortality rate was above average for Union prison. Hot, humid summers and cold Midwestern winters took a heavy toll on prisoners already weakened by poor nourishment and inadequate clothing. The prison was over- crowded much of the time and sanitary facilities were inadequate. Pneumonia and dysentery were common killers but contagious diseases such as smallpox and rubella were the most feared. When smallpox infection became alarmingly high in the winter of 1862 and spring of 1863, a quarantine hospital was located on an island across the Mississippi River from the prison.

Elijah's father, Lewis, stipulated in his will that if Elijah would stay home and take care of his mother and his younger brothers and sisters, then he would inherit the plantation upon the death of his mother. In 1830, Elijah sold 300 acres of land in Smith County, TN to Jacob Uhles. (source: Katie Nola). This would indicate Elijah's mother (Polly or Mary) had died and he was released from his obligation to take care of his mother. Elijah immediately packed up his belongings and left for Jefferson County, IL.

WIMBERLY, Rev. Elijah Wimberly ws born in the State of NC, 14 November 1800; was carried by his parents, in early life, to Jefferson Co., ILL in 1829. In 1830 he was born of the Spirit and licensed to exhort in the Methodist Church, and in that capacity he continued until 10 September 1876, when having served his generation he fell asleep. This grand old patriarch of Israel was one of nature's noblemen... (eulogy) "Uncle Lige" as he was called was educated in the school of pioneer Methodism. He leaves a wife and 7 children. - MC (27 Sept 1876)

He was carried by his parents in early life from Pendleton District of South Carolina to Sumner Co (now Smith Co) TN in Abt 1801 and he moved to Jefferson County, IL in 1830. Rev. Elijah was born in South Carolina, not North Carolina.

Elijah Wimberly started his own church between Dix, IL and Texico, IL. The church was known as Jordan Chapel Methodist Church. Elijah donated part of his farmland to the church and the cemetery is still standing.

Aaron Yearwood came in December 1826. He was accompanied by his mother, with her two sons, Joseph and Robert, and by his brother William. With William came his wife's sister Betsy, now Mrs. Watson. The father of these three ladies, Robert Rankin, Sr., came a year or so later, and after a short stay, went to Shelby County, but left here his son Robert and Mrs. Robert Yearwood.

Old Mrs. Yearwood's husband's name was Frederic; she herself died in1847. The next fall after Aaron's arrival, 1827, James Sursa, who's wife was sister to his wife and to Ward Webber, came out with his brother Jack Sursa. These men and one daughter were the children of Richard Sursa, who died in the War of 1812. Benjamin Webber came with the Yearwood's, married a Wilkerson, and settled at the Jordan or Coley Smith place on Seven Mile Creek. Ward Webber and John came three years later, 1829, the latter settling in the edge of Wayne County, while Ward located where Daniel Barfield afterward lived. Daniel was step son to James Sursa.

About the same time, 1829, William Byers came to the place still known as the "Old Byers place." Mrs. Byer's -"Aunt Nancy" - was sister to old Mr. Yearwood. Byers had a daughter already married to Joseph Brown. Pete Bruce, or Armstead W. and Moses Baugh, took one each, and the last girl (we suppose not finding a B. to suit her) was married to Fountain Garrison. He and James Garrison came in 1827, and James died of small pox a few years ago. James married a Wimberly; in two or three years after coming out, F. died.

Hi Tana,

The short answer...... No, but some of records give a hint to several possibilities.

The 1850 Census of Henry County lists the family of John Henry Williams, Jr., age 25, living in the 15th district near the family of William M. Williams, age 38. Most references indicate that the 2 families were not recently related, (and John's 2nd son, John Leonard, later married William M.'s youngest daughter, Sarah). THe census goes on to list John's wife, Elizabeth C., and 2 sons, James M. & John Leonard, ages 4 & 2 respectively, along with a child, Nancy OLIVE, age 1. Goodspeeds' History of Henry County also list the baby as Nancy OLIVE, and not Nancy WILLIAMS. Additionally, from the birth dates of John Leonard and Nancy OLIVE is highly unlikely, but not impossible, that Elizabeth could have had Nancy so soon after John Leonard.

However, more of the story lies down the road in William M. Williams household where you find Martha (Mary) OLIVE, age 17, (quite possibly, Nancy's mother or sister) living in the household along with Spencer GREEN, age 8, Davidson GREEN, age 6, Benjamin Franklin GREEN, age 3, and Lucy Ann WOOD, age 12, plus Williams' sons, Robert W, age 16, & William Cicero, age 10, and daughter, Mississippi L., age 12. It appears that William & his wife, Nancy, age 40, not only were raising their own family, but had taken in a few orphans as well. Additionally at this time, Williams wife, Nancy, was pregnant with their next daughter, Sarah, which is probably why baby Nancy OLIVE was down the road with the John & Elizabeth.

Interestingly, Nancy OLIVE Williams and James Monroe Wimberly named their 1st daughter, Mary OLIVE Shelly Wimberly, and their 1st son, David GREEN (from the William M. orphans) Wimberly.

Nancy OLIVE Williams is my wifes' 2g-grandmother. I have not been able to determine Nancy's parents so far. The records are quite sketchy. If you can provide any information, I would greatly appreciate it.

It should be noted that Asa Ellis was one of the buyers in this township in 1837 as well as John Ellis. Asa Ellis was married to Mary Wimberly. "Note Asa Ellis wanted to go to California and she would't go with him so they were divorced." (History of Pointdexter County, State of Mo., Van Buren Township, No. 30, Range 12)

The first school at Hartville was opened in 1842 by R. B.Palmer. Among the pupils were three or four of Jesse Ridens family, William H. Tate, Baily Baldwin, Nevils Young's children, John Wimberly, William and Betty Ellis, William F. Young's four boys, Alfred Young's boys, and other whose names are forgotten. In August, 1886, Hartville voted a loan of \$1,500 to build a new school house.

When John Wimberly's first wife died, he went to work on a farm in Laclede Co, MO with Churchill Cadwallader and wife Elizabeth. They lived next to John Wimberly's sister Mary Ellis.

Children Richard Wimberly (Age 10) and Elizabeth Wimberly (Age 8) are listed with Agnes Powers 33, Lebanon, Leclede County Post Office in 1870. In 1880 Richard Wimberly, Age 20, was a hired hand in Wright County.

John and Eliza Jane (Keath) Wimberly had children, Thomas Homer, John W., W. R., Ellen and Linda and an

infant that died with its mother at birth sometime around 1886.

Eliza Jane (Keath) Wimberly died in about 1886 in childbirth. The baby also died. A Mrs. Merchant made dresses for Marie Ellen Wimberly, Linda Wimberly, and Elizabeth Wimberly to wear to their mother's funeral. After Eliza Jane died, Dr. Ellis, a country doctor, took the girls home and raised them.

John took his son, John W. with him and went down river somewhere (downriver would be towards Leclede Co, MO). John Wimberly died sometime later between 1886 and 1900. It is not known where and he is suppose to be buried in a county cemetery.

The date of Clyde's birth was little different from the Census Records also, but I have been told that this can happen. Other than this, the other dates and names fit. Also, my family was in Hartville Missouri.

Notes for PARTHENA JOHNSON:

Clyde dissappeared from the family, and his brother, my great grandfather, searched for him his whole life. My grandmother, Dorothy (Wimberley) Lawson has told me many times how her father would search for his brother Clyde. Since my grandmother has lost two of her brothers this year, I have been trying even harder to find Clyde's family (She is

seventy-six years old).

I am sure that this Clyde is my Great uncle, much of the information matches. There are some differences though. Where they have Parthena Johnson, I know it was Marthena "Kate" Prock. Their family would have been far from the others for so long that this difference was bound to appear. The date of Clyde's birth was little different from the Census Records also, but I have been told that this can happen. Other than this, the other dates and names fit. Also, my family was in Hartville Missouri.

Notes for ENOCH WIMBERLY:

Both of Enoch's parents died in about 1840-1844. He was raised by foster parents, Nicholas and Delilah (Fine) Shrum, who lived in Camp Branch Township, which is at the northern part of Warren County, on a narrow strip of land bounded by Montgomery County on one side and Lincoln County on the other. Little is know about Enoch's childhood.

Enoch left Missouri with Nicholas Shrum and his family in April, 1846, and traveled by ox-train to Oregon. The following is an account of his trip told by Enoch to a family member:

"Left Warren County, Missouri, April 16, 1846, with ox-team, to cross the plains to Oregon. Crossed the Missouri river at Roachport. Buffalo in Platte country were more numerous than cattle in this country. Crossed the South Platte to the south after traveling up it for several days, thence up the North Platte to Fort Larrime. Up south side of North Platte several days. Spent July 4th at Independence Rock, Nebraska. This is an immense rock near Devil's Gate. Here the train divided and five families constituted the company the remainder of the way to Oregon. Nicholas Shrum was the captain of our train. With the party were his brothers, Thomas and "Jack" Shrum. Come by way of Fort Bridger, then to Fort Hall. We crossed the Snake river twice. Indians very peacable that year. Had no trouble with them. Immigration of '46 was the first to cross the Cascade mountains with wagons. The Shrum-Wimberly party came into the Willamette Valley by way of the Barlow Pass, south of Mount Hood, first year the route was used. Got to Foster's, the first house this side (west) of the Cascades, about the 7th of October of the same year. Came to Howell Prairie, Marion County, Oregon, seven miles east of Salem, and spent the winter. Moved in the spring to the foot of Waldo Hills, five miles east of Salem. Lived there until the spring of 1848. Went into the service of the Cayuse War of 1847-1848, and served six months."

"Went overland to the gold mines in California in the spring of 1849. Started back to Oregon by water the 19th of August, 1849. Left San Francisco on the brig Quito, and made the trip to Astoria, Oregon in 51 days. Went from there to Portland in a small rowboat. The fare from San Francisco to Astoria was \$100.00 and from Astoria to Portland \$20.00."

"Remained in the Willamette Valley until the fall of 1854, then went to Douglas County where I took a quartersection of land situated on the east fork of the Umpqua river, under the Donation Law. Was in the Indian War of 1855-1856."

"I was married on September 3, 1857, to Miss Nancy Ann Marks, who crossed the plains in 1853 with her brother-in-law, Andrew Johnson Chapman (grandfather of W. F. Chapman), and his young wife, her older sister. Also with them was the women's widowed mother, Elizabeth (Parker) Marks, who was born in 1801, while Thomas Jefferson was president. She is buried in the cemetery on the Wimberly Donation Land Claim at Glide, having died in February, 1884."

Enoch was a member of Prather's Spy Guards, and was mustered in a Deer Creek (Later called Roseburg) on March 6, 1856. He was discharged two months later on May 15, 1856. Enoch was a farmer and as most of the pioneers, a hunter.

The death of Elizabeth was confirmed by Neil McLean and Aunt Lucille in 1979. Aunt Lucille stated that her mothers' parents (Elizabeth Fields) died when her mother (Laura) was 8 or 9 years of age.

Notes for NEIL MCLEAN:

In the 1880's Keeler, CA was the southern terminus of the C&C Railroad. The primary property in that area at that time was the Cerro-Gordo Gold Mine which is currently owned by Jody Stewart.

I have copies of voting records back as far as 1878 listing Neil McLean, Lewis W. Wimberly, and Robert Lee Wimberly as residents of Keeler, CA. Sometime in the late 1880's, Neil McLean met Annie Laura Wimberly and in March, 1891, they were married at the Inyo County seat in Independence, CA. From that union were born four children all in the 1890's.

By 1900, Neil had been a freighter, or as known then a teamester, for about 20 years. Freighting in those days was an industry much like today only the technology was different. Huge quantities of freight were hauled south over the rails thru Owens Valley then unloaded at Keeler. Gold ore from the Cerro-Gordo Gold mine would be loaded on the then empty cars and hauled north. The freight would be re-loaded onto huge freight wagons pulled by 20 and 30 horses or mules. They would literally spread out across the desert floor.

In November, 1900 Neil wandered across the Nevada State line into what was to be Tonopah, NV and met a fella by the name of Jim Butler. Neil and Jim created what was probably the first non-mining contract in town. Jim hired Neil to deliver 100 horses. Neil delivered those critters in early 1901.

Over the years, Neil, the Scotsman, developed a working relationship with an Irishman named John McSweeney. On January 2, 1904, the contracting firm of McLean and McSweeney won the bid for most of the labor to lay the track for the first railroad to Tonopah, NV. That task was completed in May, 1904.

The four children born from that marriage in 1891 (Evelyn, Francis, Winsor, and Marguerite) attended school in Tonopah from late 1905 until sometime in 1912. Of the three girls, two became school teachers and the oldest, Francis, became one of the first female doctors licensed in the State of California. Neil and Laura named their only son after the guy that married them, Winsor.

Between 1905 and 1911, Neil was the primary contractor for the railroads built to Silver Peak (1906), Goldfield (1905), and the B&G (Bullfrog and Goldfield Railroad) was completed in 1907 to Rhyolite, CA. In 1911, Neill took 400 men from the Tonopah and Goldfield, NV area to Laws (near Bishop) for a sixty-day project. He completed the contract but the tracks were never laid for what was suppose to be an electric railway.

In late 1912, Laura decided she had had enough of Tonopha, NV and insisted on moving to the big city to the south, Los Angeles. Although the family moved to Los Angeles, CA, Neil continuted to have a hand in the operation of McLean and McSweeney until his death in 1922. Jim Butler died in 1923.

On July 6, 1991, the McLean family will be holding a 100 year family reunion at the Lions Club in Tonopah, NV.

Notes for ROBERT LEE WIMBERLY: Justifiable Homicide Miss Bertha Bennett Shoots Robert L. Wimberly in Self Defense.

Robert L. Wimberly, a well known miner of Downieville, was shot and instantly killed, on Friday afternoon of last week, Aug. 25th, by his sister-in-law, Miss Bertha Bennett, under circumstances, according to her statements, which caused the authorities to refuse to place her under arrest, and the coroner's jury later to fully exonerate her as a case of justifiable homicide. All the principals in the deplorable affairs are well known in Downieville, and nothing caused such a profound sensation in this peaceful and orderly community as the news of the tragedy when circulated like wild fire early Friday evening.

County Coroner McDonald and County Physician Duty immediately repaired to the scene on the old Jenkin's ranch on the South Fork of the North Yuba. Meanwhile Miss Bennett and her sister, the wife of the deceased, started for Downieville, Miss Bennett with the purpose to give herself up to Sheriff McGregor. A statement of the facts having been given District Attorney Redding, the ladies, on his suggestion as well as that of Sheriff McGregor, returned to the ranch to await the verdict of the coroner's jury. Miss Bennett's home is in Grants Pass, Oregon, in which she and her sister were born. Since Mrs. Wimberly's residence in Downieville, Miss Bennett has occasionally spent her summer vacation here.

It seems that Robert Wimberly had become infatuated with her and she wisely chose to foreshorten her present vacation and return to Oregon the latter part of last week. According to her testimony to the coroner's panel last Saturday she was engaged the day before in assisting her sister about the house in domestic duties, and had gone to the spring some distance from the house for a bucket of water, when Wimberly appeared and at the point of a pistol compelled her to accompany him to a distant part of the field on the hillside, beyond a rise out of view of the house. He overcome her protests by threatening her. Just before reaching the spot she momentarily lost consciousness and on coming to, found Wimberly attempting to rape her person. Her resistance was met with threats of death to herself and himself, she alleged. Her pleas and appeals to his mercy, she stated, were also unavailing. He then laid the pistol on the ground but within her reach. Taking it up, she declared, she threatened to shoot if he did not desist. He attempted to take the weapon from her, whereupon she pulled the trigger. The bullet entered his head at the left ear and penetrated his brain. Death was instantaneous. Miss Bennett went to the house and told her sister what had happened and the two women went to the place of the struggle. Then they started for town after sending Jim Alexander to notify the authorities.

Miss Bennett's appearance and that of Wimberly's body corroborated her story and, as stated above, the authorities decided not to place her under arrest.

Miss Bennett's testimony at the coroner's inquest was in accordance with the main facts as related above, and the jury promptly returned a verdict of justifiable homicide. She had shot, according to her testimony, to save her life and honor.

Neil McLean think things were not kosher in the shooting of Robert Wimberly. Martha, Robert's widow, married a couple of months later and Bertha Bennett, the alleged victim, showed up in the 1910 census as a permanent member of the houshold.

Funeral services were held over the deceased in the Methodist Church on Sunday afternoon. Rev. L. P. Walker preaching an appropriate sermon and extending the sympathies of the community to the bereaved widow and children. The attendance at the services were large. Interment of the remains took place in the Downieville cemetery.

Wimberly was a native of Placerville, Eldorado County, Cal, and at the time of his tragic demise was nearly 42 years old. He had been a resident of Downieville 12 years, and for some time interested with Fred Bosch, Jr., in a group of mines in the Gold Valley ridge country. The property or its management, caused a disagreement between the partners and their affairs were carried into court. The property was sold by order of the Court last Monday, Val Hartling being commissioner. The trouble terminating in the sale appears to have worried Wimberly and of late he had been drinking. It is known that he was under the influence of liquor the day of the tragedy. Wimberly had a wide circle of acquaintances and was held in high esteem by his friends, being regarded by them as a hard working and honest miner.

Mrs. Wimberly's testimony was to the effect that the deceased, her husband, had some weeks ago shown an infatuation with her sister, and also laterly had drank very heavily.

Miss Bennett, who is 18 years old was a favorite here socially, and all deplore the unfortunate affair. Her return to Oregon has been postponed for the present.

Notes for LEWIS MONROE WIMBERLY:

Lewis Monroe Wimberly was a school teacher at Hopewell School. Hopewell was founded in 1818. Lewis Wimberly was also a minister at Hopewell Primitive Baptist Church and Union Primitive Baptist Church. Records were lost for the Mt. Carmel Church, but believe he was also the minister at that church.

At the age of twenty-one, he was tax collector and assessor of Fayette County, AL and was treasurer and superintendent of education for a number of years for Lamar County. He was mayor of Vernon, AL for a long period; during the war between the states, he was captain of Company G, Twenty-Sixth, Alabama, CSA.

Lewis Wimberly was still living in 1902. He was a veteran of the Civil War having fought with the Confederate Army. He was attached to the Alabama 26th, Company A. In Special Order Number 130, A. & I.G.O., by command of the Secretary of War, June 1, 1863, shows Lewis M. Wimberly was a Captain in Company I, 26th Alabama Volunteers. There is a document that shows Lewis M. Wimberly resigned from Company I in January, 1862.

Captain Lewis M. Wimberly received a severe wound in the lungs at Gettysburg, PA.

The 26th Alabama Infantry Regiment was formed at Tuscumbia in December, 1861, using the 7-company 3rd AL Infantry Battalion as a nucleus. Men were recruited from Fayette, Marion, Tuscaloosa, Walker, and Winston counties. Two companies under Major J. S. Garvin were soon ordered to Ft. Donelson and captured in that fight on 16 February 1862. After being exchanged, they joined the regiment in Virginia. It was in Gen'l Gabriel James Rains' Brigade at Yorktown, under fire but with few casualties. After moving up to Richmond from Williamsburg, the regiment was assigned to Rodes', O'Neal's, and Battle's Brigade, Army of Northern Virginia. It lost 22% of its number at Seven Pines and was reduced to half strength at the end of the Peninsular Campaign. As the army crossed the Potomac, the 26th was in the van and engaged in both Boonsboro and Sharpsburg, losing 10 killed and 45 wounded in those struggles. Wintering on the Rappahannock, the 26th was present at Fredericksburg. It was then in the flank attack with Jackson's Corps at Chancellorsville (116 casualties), Col. O'Neal leading the brigade.

The 26th moved to Gettysburg and fought there with losses of 7 killed and 58 wounded, with 65 missing, They

retired with the army into Virginia and skirmished at Kelly's Ford and Mine Run. During the winter, the Alabama legislature petitioned to have the regiment sent home for recruiting. By February, 1864, the regiment was stationed at Andersonville, GA, guarding Union prisoners of war. In the summer (June), the 26th was attached to Brig. Gen'l James Cantey's Brigade and fought with the Army of Tennessee from Atlanta to Bentonville. It moved with Gen'l John Bell Hood into Tennessee where it was badly hurt at Nashville. Only a remnant surrendered at Greensboro, North Carolina, to which place it had been transferred.

Notes for GILBERT BEBEE WIMBERLY: Gilbert Bebee Wimberly, M. D., of Reform, AL was born in Fayette, County of Fayette, December 12, 1869, whence he removed to his present abode. He received an academic education at Bernon institute, Vernon, Alabama, entered the Memphis Hospital and Medical college in 1890, and graduated from the Medical College of Alabama at Mobile in 1892, with the degree of doctor of medicine.

He began the practice of medicine at Reform the same year, and here he has built up a large practice, making a specialty of surgery. He is also extensively engaged in merchandising. The Doctor was the first mayor of Reform, and held that office for a number of years. It was due to his efforts that the town was incorporated.

His military career embraced a term of eight years as first lieutenant of Company M, Alabama national guard, and an appointment as surgeon of the Second regiment, Alabama national guard, being its surgeon when the war between America and Spain came on.

He is secretary of the Democratic executive committee for the sixth congressional district. He is a Baptist in faith and practice, a member and worshipful master of Fellowship lodge, Free and Accepted Masons, Reform, AL; of Tuscaloosa chapter and commandery; of Zamora Temple, Birmingham, Alabama.
